RAJASTHAN STATE LEGAL SERVICES AUTHORITY JAIPUR NOTIFICATION

Jaipur, March 20, 2012.

G.S.R. 5 :- The Rajasthan State Legal Services Authority. In exercise of the powers conferred on it under section 29-A of the Legal Services Authority Act. 1987 (Act No. 39 of 1987) hereby makes the following regulations further to amend the Rajasthan State Legal Services Authority Regulations. 1999 namely:-

1. Short title and commencement :- (1) These Regulation may be called the Rajasthan State Legal Services Authority (Amendment) Regulation, 2012

(2) They shall be deemed to have come into force with effect from 20-03-2012.

2. Amendment of regulation 22 :- The existing Sub regulation (2) of regulation 22 of the Rajasthan State Legal Services Authority, 1999 herein after referred to as the said regulation shall be substituted by the following namely:-

“(2) In the first instance endeavour shall be made to arrange services of the Legal Practitioner on honorarium basis. If such services cannot be so arranged or cannot be so arranged without providing assistance by another legal practitioner the concerned Committee/District Authority may appoint a legal practitioner and pay the fee at the following rates, namely:-

(a) Court of Tehsildar, Executive Magistrate. Civil Judge (Junior Division) cum Judicial



- Magistrate, Sub Divisional Officer, Assistant Collector and other similar court etc. Rs. 2000/- per case and expenses of Rs. 500/- per case in addition to fee prescribed.
- (b) Court of Collector-cum District Magistrate, Additional Collector - cum Additional District Magistrate, Civil Judge (Senior Division) cum Chief Judicial Magistrate and Civil Judge (Senior Division) cum Additional Chief Judicial Magistrate, Revenue Appellate Authority and other similar Tribunals Rs. 3000/- and expenses Rs. 500/- per case.
- (c) Court of District & Sessions Judge, Additional District and Sessions Judge, Rs. 4500/- and expenses Rs. 500/- per case.
- (d) High Court Rs. 5500/- and expenses Rs.1000/- per case.
- (e) In any case for reasons to be recorded in writing it is considered by the Chairman to be of such nature/importance requiring payment of higher fees to the Legal practitioner, may pay higher fees as it deems fit.”

Provided that in miscellaneous and petty cases like Bail applications and revision petitions of case under section 107, 125, 145, 133 Cr. P.C. etc. 1/3 amount of fee as specified in clause (a) to (d), as the case may be, and expenses Rs. 500/- per case shall be paid.

Provided further in the withdrawal cases ½ amount of fee as specified in clause (a) to (d) shall be paid.”

3. Amendment of regulation 37 - In regulation 37 of said regulations for the existing expression “Rs. 150/-”, the expression “Rs. 500/-”, shall be substituted.
