Rajasthan State Legal Services Authority hereby makes the following amendment in point - I(1) of Circular no. F-2(149)/RSLSA/DS-I/FWC/2017/03 dated 03.10.2017 Protocol/ Guidelines for Family Welfare Committees relating to honorarium to chairman and members of Family Welfare Committee as follows:-

**I - Honorarium to the Chairman/ Members of FWC:**

1. The Chairperson and Members of the Committee would be paid honorarium as per sitting basis i.e. the Chairperson of the Committee would be paid Rs. 1500/- (Rupee One Thousand Five Hundred only) per sitting and the Members would be paid Rs. 750 (Rupee Seven Hundred Fifty Only) per sitting.

**Note:** Point I (2 to 4) will remain same.

**The above amendment will be effective from date 01.06.2018.**


