ORDER

Pursuant to the Notification No. RHC/Exam. Cell/2016/1095, dated 16.08.2016, following candidates, declared successful in the recruitment to the post of Clerk Grade-II are hereby appointed as Clerk Grade-II (Probationer Trainee) on the fixed remuneration of Rupees 8,910/- per month initially for a period of two years from the date of joining as prescribed by the Rajasthan State Government vide its Notification dated 08th June, 2015, subject to following conditions:-

- 1. Appointment in the said post is purely temporary in nature for a period of two years and the same will be extended on the basis of work performance and conduct of the incumbent.
- 2. Service of incumbent shall be liable to be terminated at any time without prior notice on the basis of statutory constraint/objection, if their services are not found satisfactory during the probation period of two years.
- 3. Appointment of incumbents would be liable to be terminated without any prior notice, if adverse report or concealment is found in the Police Verification of the candidates.
- 4. They will not get Annual Grade Increment, allowances and honorarium during the Probation period.
- 5. New Pension Scheme and New Medical Attendant Rules will be applicable on them.
- 6. They must submit medical fitness certificate as prescribed in Rule 10 of Rajasthan Service Rules, 1951 at the time of joining.
- 7. Appointment of candidates on the said post shall be subject to Character Verification through the Police.
- 8. This provisional appointment would be subject to verification of genuineness of documents.
- 9. They have to join their duties on or before 14.10.2016 in the office of Rajasthan State Legal Services Authority (RSLSA), Jodhpur/Jaipur or Rajasthan High Court Legal Services Committee (RHCLSC), Jodhpur/ Jaipur, as mentioned in this order, failing which, their Appointment order shall stand cancelled automatically without any further notice.
- 10. Pay of these Probationer-Trainee Clerk Grade-II will be fixed in the running pay band PB-1, 5200-20200 & Grade Pay 2400 after successful completion of probationtraining period and they will be entitled to get other allowances as per rules.
- 11. They are posted at the place shown against their names.
