OFFICE ORDER

In compliance of mandatory directions under Sub Section (2) of Section 16 of the Juvenile Justice (Care and Protection of Children) Act, 2015, Rajasthan State Legal Services Authority, hereby, with the prior approval of Hon'ble Executive Chairman, RSLSA constitutes High Level Committee for Effective Implementation of Juvenile Justice (Care and Protection of Children) Act, 2015 with immediate effect for a initial period of two years from the date of its Constitution.

Following shall be the Chairman/Secretary/Members of the High Level Committee:-

1. Hon'ble Executive Chairman, RSLSA (Chairman)

2. Member Secretary, RSLSA (Secretary)

3. Principal Secretary, Home Department, Government of Rajasthan (Member)

4. Principal Secretary, Social Justice and Empowerment Department (Member)
(Secretary responsible for Implementation of JJ Act)

5. Sh. Govind Beniwal, Project Director, Antakshari Foundation, NGO (Member)

This High Level Committee shall discharge following functions:-

- 1. This committee shall review number of cases pending before the JJ Board in the State of Rajasthan.
- 2. This committee shall review the duration of such pendency, nature of the pendency and reasons thereof and may issue appropriate directions to JJ Boards, Government functionaries and other concerned persons for effective implementation of JJ Act.
- 3. This committee may monitor the effective implementation of the directions issued by Hon'ble Apex Court in Sampurna Behura Vs. Union Of India & Ors, 2011 (9) SCC 801
- 4. This committee may issue guidelines for effective implementation of directions issued by Hon'ble Apex Court and Hon'ble Rajasthan High Court with regard to JJ Act.

- 5. The High Level Committee may issue directions for effective implementation of legal aid services in compliance of mandate under Article 39A of Constitution of India & Legal Services Authority Act, 1987 in respect of Juvenile Justice System.
- 6. The High Level Committee may monitor the effective implementation of directions given by NALSA with regard to JJ Act.

The committee shall adopt its own procedure of working. The committee may organize its meeting at least once in six months.
