**जी.एस.आर.32** :-विधिक सेवा प्राधिकरण अधिनियम, 1987 (1987 का केन्द्रीय अधिनियम सं. 39) की धारा 28 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए राज्य सरकार, राजस्थान उच्च न्यायालय के मुख्य न्यायमूर्ति के परामर्श से, राजस्थान राज्य विधिक सेवा प्राधिकरण नियम, 1995 को और संशोधित करने के लिए इसके द्वारा, निम्नलिखित नियम बनाती है, अर्थात्:-

1. संक्षिप्त नाम और प्रारम्भ.- (1) इन नियमों का नाम राजस्थान राज्य विधिक सेवा प्राधिकरण (संशोधन) नियम, 2017 है।

(2) ये तुरन्त प्रवृत्त होंगे।

2. नियम 6 एवं 7 के अधीन अनुसूची-क का प्रतिस्थापन.- राजस्थान राज्य विधिक सेवा प्राधिकरण (संशोधन) नियम, 2013 के अधीन अनुसूची-क के स्थान पर निम्नलिखित प्रतिस्थापित किया जायेगा, अर्थात्:-

**G.S.R.32** .-In exercise of the powers conferred by section 28 the Legal Services Authorities Act, 1987 (Central Act No. 39 of 1987), the State Government in consultation with the Chief Justice of the Rajasthan High Court, hereby makes the following rules further to amend the Rajasthan State Legal Services Authority Rules, 1995, namely:-

- 1. Short title and Commencement:-** (1) These rules may be called the Rajasthan State Legal Services Authority (Amendment) Rules, 2017

- 2. Substitution of Schedule A:-** The existing Schedule A appended to the said rules shall be substituted by the following, namely:-
