देश में कोरोना वायरस के संक्रमण के तहत लागू राष्ट्रीय लॉकडाउन अवधि दिनांक 14.04.2020 को वृद्धित करते हुए लॉकडाउन की अवधि दिनांक 03.05.2020 तक की गयी है। लॉकडाउन अवधि के दौरान दिनांक 19.04.2020, 25.04.2020, 26.04.2020 एवं 03.05.2020 का राजकीय अवकाश है। इसके अतिरिक्त कार्यादिवसों के लिए विधिक सेवा कार्यक्रमों एवं गतिविधियों के क्रियान्वयन के लिए इस कार्यालय द्वारा आदेशिका दिनांक 26.03.2020 (प्रतिलिपि संलग्न) द्वारा राजस्थान राज्य विधिक सेवा प्राधिकरण एव समस्त अधीनस्थ कार्यालयों के लिए दिशा-निर्देश जारी किये गये थे।

That after declaration of National lockdown of 21 days w.e.f. 25th March 2020 by Hon'ble Prime Minister on 24th March 2020, the Union Home Secretary, Ministry of Home Affairs, Government of India, New Delhi had subsequently issued order No. 40-3/2020-DM-I(A) dated 24th March 2020, whereby National lockdown began from 25th of March 2020.

Whereas due to threat of pandemic coronavirus and immobilization of public at large, regular and routine working of DLSAs, RSLSA and permanment Lok Adalat offices has become quite difficult. Therefore, in wake of unprecedented and uncertain situation at present, normal functioning of offices requires to be moderated.

That during 21 days of present lockdown, already having holidays on 28th & 29th of March and on 2nd, 4th, 5th, 6th, 10th, 11th, 12th and 14th in month of April 2020 for Permanent Lok Adalats. As per directions issued by Hon'ble High Court of Rajasthan, Ld. lawyers and litigants are not permitted to appear in person before the Courts including Hon'ble High Court, hence, after approval, following working arrangements are made till 14th April 2020, for PLAs, DLSAs and RSLSA in view of threat with spread of COVID-19 epidemic:

- 1. Regular sittings of all whole time Permanent Lok Adalat in Rajasthan (total-23) may continue to be suspended till 14th April 2020. The declaration of compensatory working days, if any, may be considered after the situation becomes normal. All kind of cases before PLAs will be instituted after 14th April 2020, as Hon'ble Supreme Court has already extended period of limitation under Article 141-142 of the Constitution of India, for institution of all kinds of cases.
- 2. All Public entries to the campus of RSLSA and DLSAs across Rajasthan may continue to be restricted till 14th April 2020.
- 3. All kinds of Weekly and Monthly inspections, as prescribed by RSLSA for DLSAs may be carried out by the Secretary of DLSA, as and when required, under the guidance and supervision of the Chairperson of DLSAs.
- 4. DLSAs Secretary are hereby directed to function through bare minimum staff but with the direction that in case of emergency or if requested by the

District Administration for public cause, services of staff of DLSAs & PLAs will be utilized as per the need for public service. During this period staff of PLA will work under directions of the Secretary of respective DLSA.

- 5. DLSAs shall function & provide services as per need and requirement, in view of situation at local level under guidance of the Chairperson of DLSA but in coordination with the District Administration.
- 6. RHCLSC Jodhpur or Jaipur may function as per directions of Hon'ble Chairperson of RHCLSCs.
- 7. RSLSA at Jodhpur will also function as per directions of MS, RSLSA but with bare minimum staff.
- 8. RSLSA HQ at Jaipur will function with bare minimum staff and lesser number of officers but deployment would be on rotational basis.
- 9. Legal aid and awareness through Emails, video Conferencing and also through other digital platforms will continue to be functional. Efforts shall also be made to promote awareness through social media.
- 10. All officers and staff, if not called in person at any office campus, must be available at duty HQ and keep their mobile & whatsApp on active mode.
- 11. One mobile van is already made available for use by Medical team and if any other mobile van, requisitioned for public distribution of goods or for use by Medical staff, same may be provided to the concerned authority.
- 12. DLSAs are requested to make due payment to PLVs and Panel Lawyers for work done upto March 2020, subject to availability of budget and work performance report, immediately through their bank accounts, as banking services are operational and included in essential services.
- 13. All establishments are hereby directed to utilize budget of present year 2019-20 upto 27th March 2020 and all prepared bills to be sent by email to treasury as per procedure prescribed vide F.5 (94-95) Treasury/IFMS/3567-3766 dated 23.03.2020 issued by the ACS (Finance), GoR.
