In compliance of directions of Hon'ble Chairman, Rajasthan High Court Legal Services Committee, Jaipur (RHCLSC, Jaipur in short) and in exercise powers conferred under Rajasthan State Legal Services Regulations, 1999 read with the National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010, it was proposed to prepare Separate Panel of lawyers for (1) Civil Matters (2) Criminal Matters, (3) Constitutional Law & Writ Matters (Other than service cases), Environmental Law, (5) Labour Law & Service Matters, (6) Matrimonial (7) Matters before the Central Administrative Tribunal/ Armed Forces Tribunal, to present and plead the cases on behalf of the persons provided with legal aid under Section 12 of the Legal Services Authority Act, 1987 as per directions of RHCLSC, Jaipur.

Applications were invited from Advocates by Notice No. 5(14)/RSLSA/FTS/Panel Advocates/2017/3403, dated 06.11.17. Notice No. RHCLSC/Jaipur/3787, dated 07.12.2017 and Revised Notice No. F-5(14)/RSLSA/FTS/Panel Advocate/2017/3976, dated 31.01.18 Total 264 learned Advocates submitted their applications for empanelment as Panel Lawyers of RHCLSC, Jaipur.

Looking to the volume of work and applications received, it was decided to prepare a panel of 40 lawyers for Criminal Matters, 30 lawyers for Civil Matters, 25 lawyers for Constitutional Law & Writ Matters (other than Service cases), 25 lawyers for Labour Law & Service Matters, 20 lawyers for Matrimonial Disputes, 20 lawyers for matters before the Central Administrative Tribunal/ Armed Forces Tribunal and 10 lawyers for matter relating to Environmental Law.

The competence, integrity, suitability and experience of all the above 264 applicants was examined by Hon'ble Chairman Sb., RHCLSC, Jaipur in consultation with Sh. N.M. Lodha, Learned Advocate General of State of Rajasthan and Sh. Anil Kumar Upman, President, Rajasthan High Court Bar Association, Jaipur.
